Alicia,

We enclose a version of your Compliance Fig 4 April 2023 'A' Water table wells overlaid on the Strada Pits Rehabilitation Plans. These contours are based on the data as shown on your Fig 4 converted to CGVD28 for comparison and lightly smoothed. We are uncertain how your contours were generated or why they are so different.

We note that towards the western boundary in the Melancthon Pit # 1 and in the Prince Pit the 500 m water table contour is as much as 10 m above the 390 m asl specified Pit rehabilitation floor or 11.5 m above the Melancthon # 1 Site Plan implied water table. Other areas also have the water table above the Site Plans rehabilitation pit floors.

I suggest part of this issue is an inadequate number and distribution of groundwater monitors (No Data areas). Alternatively the Site Plans may contemplate extraction into the site water table gradient. I also suggest that it is not in Strada (or NDACT) interest for this Site Plan conflicting information to be circulated to approval agencies until properly vetted.

We can discuss this further at our Friday scheduled meeting.
