I am opposed to the filing and content of Strada's Feb 1, 2025 Quarry Site Plan application. This filing is in bad faith and breaches my understanding of the admirable community process set in place with NDACT. This is not smart public relations, undermines NDACT and ignites the opponents.

My evolving position is that Strada should withdraw this application until the NDACT / Strada science based decision process has played out. However it may too late now that the horse is out of the barn.

We are now in a ridiculous Peer Review fifth iteration because of Strada's consultants lack of cooperation throughout the process. By comparison the WSP CBM Caledon Quarry has only gone through two iterations. This number of Strada iterations is extremely frustrating and I am far over budget in this review process.
