Grant and Carl,

I am currently reviewing these Strada April 2025 Issues Response documents and request the following clarifications at your earliest convenience.

1. Confirmation of the Earthfx / Tatham / NRSI Report version(s) being quoted in both the April 2025 Earthfx and WSP responses (Appendix A, B, C, D, E etc)?
2. Confirmation of the Site Plan version being cited.
3. A copy of the 2024 Pit Compliance Report (Tatham March 2025) as referenced on Earthfx Response pg 9 last para.
4. Digital (.xls) file of all Tatham Pine and Boyne River headwater stream flow monitoring data as collected since early 2024 to about April 30, 2025 including that referenced in the Earthfx April 2025 Response.
5. WELLness survey information collected to date (Earthfx pg 11 last para). Although we have already processed edited MECP water well data bases for the Quarry Influence Area, we have not yet undertaken systematic analyses of private water well quantity and quality impacts, anticipating the WELLness data would eventually become available for database integration.
